## THE 2024 USBC OPEN CHAMPIONSHIPS GIVEAWAY

## **OFFICIAL RULES**

**1. HOW TO ENTER:** NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. The 2024 USBC OPEN CHAMPIONSHIPS GIVEAWAY is sponsored by United States Bowling Congress ("Sponsor"), 621 Six Flags Drive Arlington, TX 76011 (the "Giveaway Address").

**2. ELIGIBILITY:** The Giveaway is comprised of three hundred and two (302) separate random drawings (each a "Team Squad Drawing"), one for each of the scheduled squad times (2 p.m. and 9:30 p.m. daily) during the 2024 USBC Open Championships in Las Vegas, Nevada between Feb. 23, 2024, and July 29, 2024 (the "Championships"), Those who are eligible in accordance with these Official Rules and compete as a registered bowler in a team squad (five-person team) at the Championships will automatically be entered in the Team Squad Drawing corresponding to their registered squad time. Entry in a Team Squad Drawing is open to legal residents of the fifty (50) United States and D.C. (the "Eligible Territory") who are 18 years or older at the time of entry (competition date or postmark date for AMOE (defined below)) and who are not: (i) employees of Sponsor or its affiliates or entities involved with the administration or promotion of this Giveaway or (ii) an immediate family member or household members of such persons. Participants agree to be bound by the decisions of Sponsor with respect to this Giveaway and such decisions shall be final.

**3. HOW TO ENTER:** Between Feb. 23, 2024, and July 29, 2024, **Individuals who have registered to compete as a bowler in the Championships on a team squad and will be automatically entered in the Giveaway. Alternatively,** an eligible entrant may enter without participating in a team squad by printing entrant's name, mailing address, telephone number, email address, and 2024 USBC OPEN CHAMPIONSHIPS GIVEAWAY on a 3" x 5" index card or piece of paper, and sending it in an envelope by postage paid mail to: South Point Bowling Plaza, Attn: Giveaway Entry Request, 9777 Las Vegas Blvd. South, Las Vegas, NV 89183 (the alternate method of entry ("AMOE"). Limit one index card submitted per outside envelope. Mail-in entries must be received no later than July 29, 2024. A mail in entry will be given one entry in the Giveaway for the next scheduled Team Squad Drawing. **Limit one entry per person total in the Giveaway regardless of means of entry.** All entries submitted become the property of the Sponsor and none will be returned. If for any reason the Giveaway is not capable of being conducted as contemplated in the Official Rules, including if due to technical failures which compromise the administration or integrity of the Giveaway, Sponsor, in its sole discretion, reserves the right to terminate or modify the Giveaway. Sponsor reserves the right to disqualify any entrant who tampers or attempts to tamper with the entry procedure or the Giveaway or violates these Official Rules.

**4. GIVEAWAY PRIZE; ODDS.** One (1) Prizewinner selected at random in a Team Squad Drawing (which is conducted at the Championships during the announcements prior to the scheduled squad time) (the "Winner") will receive the following prize: one (1) ten dollar (\$10) gift card for the USBC Bowling Store located at South Point Bowling Plaza in Las Vegas, NV (Approximate Retail Value \$10) (the "Prize"). No transfer or substitution of prize permitted except where required by law. If the Prize becomes unavailable, the Sponsor may award a substitute prize of equal or greater value. Odds of winning depend on the number of eligible entries received for a Team Squad Drawing. Taxes on the Prize are the sole responsibility of the Prizewinner. All expenses, costs and fees not expressly included above are the sole responsibility of Prizewinner. The total number of prizes to be awarded in each Team Squad Drawing is one (1) Prize (with a total of three hundred and two (302) prizes total across the entire Giveaway).

**5. WINNER SELECTION AND NOTIFICATION**: Sponsor will announce the selected entrant following the corresponding Team Squad Drawing (the "Drawing"). The tentative Prizewinner will be

deemed the Winner if such person is in compliance with the Official Rules and elects to receive the Prize. Sponsor will use reasonable efforts to notify the tentative Prize winner via U.S. Mail and/or e-mail and/or telephone within seven (7) days of the drawing if the selected entrant is not present at the Team Squad Drawing. Any Prize awarded to an individual not present at the Team Squad Drawing will be sent via U.S. mail. In the event that a particular Prize is not awarded based on the first random drawing in a Team Squad Drawing, Sponsor will repeat the above process until such Prize is awarded. Except where prohibited by law, the Prizewinner further grants to the Sponsor the right to use such Prizewinner's name, photograph, voice, likeness and city of residence for purposes of advertising or promoting and publicizing the efforts and activities of the Sponsor and the Giveaway without further consideration. YOU AGREE TO THE FULL EXTENT PERMITTED BY LAW TO RELEASE AND HOLD HARMLESS SPONSOR, ITS AFFILIATES, PARENT, SUBSIDIARIES, ADVERTISING AND GIVEAWAY AGENCIES, AND ALL OF THEIR RESPECTIVE SHAREHOLDERS, OFFICERS, DIRECTORS, EMPLOYEES, ASSIGNS, MEMBERS, REPRESENTATIVES AND AGENTS (COLLECTIVELY, THE "RELEASED PARTIES"), FROM AND AGAINST ANY CLAIM OR CAUSE OF ACTION ARISING OUT OF PARTICIPATION IN ANY PART OF THE GIVEAWAY (INCLUDING, WITHOUT LIMITATION, PREPARING FOR OR PARTICIPATING IN OR SUBMITTING ANY ENTRY AND/OR FROM ANY GIVEAWAY OR PRIZE RELATED ACTIVITY) OR RECEIPT OR USE OF ANY PRIZE, INCLUDING PROPERTY DAMAGE, PERSONAL INJURY OR DEATH. YOU HEREBY REPRESENT AND WARRANT THAT YOU HAVE READ THESE OFFICIAL RULES AND ARE FULLY FAMILIAR WITH THEM AND BOUND BY THEM.

All entries submitted become the property of the Sponsor and will not be returned. If for any reason the Giveaway is not capable of being conducted as contemplated in the Official Rules, Sponsor may terminate or modify the Giveaway. Sponsor may disqualify any entrant who tampers or attempts to tamper with the entry procedure or the Giveaway or violates these Official Rules.
