# **LEAGUE RESOURCES**

#### League finances

We cannot stress enough how important it is to follow the rules and procedures for league finances. League funds must be deposited within seven (7) days of receipt. The president must do the math monthly to <u>verify the league account</u> has the correct amount of money on deposit. Learn more about league finances.

#### **Position rounds**

What is a position round? A position round, as defined in <u>Rule 107</u>, is a session in the league schedule where the match pairings are based on the current team standings. In most cases, the team in 1<sup>st</sup> place will bowl against the team in 2<sup>nd</sup> place, 3<sup>rd</sup> place will bowl 4<sup>th</sup> place and so on down the line.

The most frequent questions submitted to Rules regarding position rounds are as follows:

1 – **How do we make the pairings when we have teams with the same records?**Unless the league has adopted another procedure based on pinfall, ties for <u>determining the pairings</u> on a position round can be broken using the total scratch pinfall in scratch leagues and total pinfall with handicap in handicap leagues. Remember, this is only to break the ties to determine who will bowl who in a position round...not to break ties of the position round matches.

### 2 - Can a substitute be used in a position round?

Yes, substitutes may be used unless the league rules state otherwise. USBC rules do not restrict the use of any individual during specific league contests. However, leagues do have the option to adopt special eligibility requirements to participate in positions rounds, such as having a minimum number of games requirement to participate or restrictions on the use of substitutes in these matches.



**Don't forget...** about adopting the prize fund. Rule 106a requires proposals to be presented for adoption by the fifth week of the schedule. League presidents, it is your duty to ensure a prize list is adopted in a timely manner. If this has not been done, please activate a prize fund committee to get at least one proposal submitted to the league for adoption as quickly as possible. ### Athlete Safety/RVP

The Registered Volunteer Program is designed to create awareness about emotional, physical and sexual abuse through education and prevention policies.

All league officers must be RVP compliant if they are operating an **Adult/Youth** or a **Youth** league. These consist of any league in which a minor (17 years of age or younger) is allowed to participate.

If you conduct a youth league or youth/adult league as a league officer, you must be a Registered Volunteer. You will need to successfully complete SafeSport training and a background screen through NCSI. In addition, you must follow all policies in the Athlete Safety/RVP Handbook when your competition allows bowlers under the age of 18 to participate.

By certifying an event, you are responsible for adherence to USBC's policies and procedures as found in the USBC Playing Rules book, Athlete Safety & RVP Handbook and all other policies and procedures. Failing to do so could result in USBC removing the certification status.
