ENTRY FEE BREAKDOWN

- All prize money will be returned 100%. Prize ratio will be at least 1:8 for all divisions, events.
- Entry fee is \$70 per event/per bowler (breakdown per event is \$40 for prizes and \$30 for expenses); optional all-events is \$15 (\$13 for prizes, \$1 for expenses and \$1 to Team USA). Total is \$225 PER BOWLER for team, doubles, singles and all-events.
- A \$25 processing fee per team applies to all registrations. Doubles/Singles-only entry is considered a "team."

The restrictions for divisional placement are as follows:

- 1) Regular Division bowlers (entering averages of 176 and above) may not compete in Classified Team or Classified Doubles, regardless of composite average.
- 2) Teams in the Standard Division may have no more than two bowlers with an average of 176 or higher.
- 3) Teams in the Classified Division may have no more than two bowlers with an average between 156-175.

ENTRY FORM INSTRUCTIONS

- A. Complete captain information.
- B. Enter primary companion team information if you wish to bowl with your companion team on the same pair of lanes.
- C. Your team's hometown (to be displayed on scoreboard) and your team's home bowling center.
- D. Team lineup: please enter all information requested for each bowler (name, address, city, state, zip code, email address, birthdate, USBC ID # located on member card). This information assists in finding member and verifying averages.
- E. Roster No. 6 is for a bowler only entering Doubles & Singles.
- F. Enter your doubles pairings.
 - Doubles & Singles squad times are assigned on first-come basis with full fees.
 - Doubles/Singles-only entries scheduled after Jan. 2, 2023.
 - No half pairs of doubles are allowed.
- G. Method of payment. Money order, certified check or cashier's check.
 - A processing fee applies to all payments.
 - Refunds will be issued to any captain who pays at least the team entry fee and requests cancellation in writing by the official close of entries date. Refunds are subject to a \$50 service charge.

TERMINATION / RELEASE CLAUSE

To the Chief Executive Officer of the United States Bowling Congress: We, by our captain and agent, hereby make application to participate in the 2023 USBC Open Championships events listed and tender the entry fees required therefore. We warrant that we are USBC members. We agree to abide by all tournament and playing rules and regulations prescribed by USBC, including all provisions set forth on this form. We specifically agree for ourselves and any replacements chosen by or for us that if we are not eligible for participation and/or cannot bowl in the USBC Open Championships, then our prize, bowling, and expense fees shall be forfeited and all sums tendered by us as prize, bowling and expense fee may be retained by USBC as liquidated damages. The entrants whose names appear hereon or their authorized replacements hereby agree that the USBC, its officers and agents shall be liable only to the extent of returning entry fees, less expenses, if and when these entrants shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto or resulting therefrom, fires, labor difficulties, terrorism or threats of terrorism, or other causes beyond the control of USBC. We further agree that USBC may use our names and likenesses (including video) for promotional purposes at no cost to us and with no fees being paid by us. The entrants whose names appear on this application and/or authorized replacements hereby agree that the USBC, and its officers and agents, shall not be liable for any injury resulting from participation in bowling in the USBC Open Championships, absent willful or gross negligence on the part of USBC.
