

ATTENDEE INFORMATION

Welcome to The Orleans and the 2022 USBC Convention. We are so excited to have everyone Together Again! The following information will assist you in the procedures for the USBC Convention and Annual Meeting.

This year, the USBC Convention and Annual Meeting will have informative seminars, annual Meet for the Cure and Bowlers to Veterans Link celebrations, legislative session and elections for the USBC Board of Directors.

All USBC members are entitled to address the delegation during the Annual Meeting, so it is important for all attendees to have registered and received the appropriate credentials.

WHAT YOU WILL NEED

- Credentials
- Convention Program. This program has schedules and information you will need during Convention, as well as the legislation for Wednesday afternoon's Annual Meeting.
- Notepad and pens
- Casual clothing is acceptable for seminars and the Annual Meeting.

ASSOCIATION REPRESENTATIVES

Written or verbal authorization from the association manager or president is required to add a new delegate/alternate or to change an alternate to a delegate. Association delegates who change to athlete-delegate status will be verified by the registration staff and issued a new badge.

SEMINARS & USBC HALL OF FAME DINNER

Seminars are on a tight schedule, so please plan to arrive at least 10 minutes early.

For those who have purchased tickets, there will be two USBC Hall of Fame ceremonies this year. The Class of 2020 will be honored Tuesday, April 26 in the French Quarter Ballroom. The reception starts at 5:30 p.m., and the dinner will start at 6:30 p.m.

The Class of 2021 and Class of 2022 will be inducted on Wednesday, April 27 in the French Quarter Ballroom, with the reception starting at 5:30 p.m. and the dinner starting at 6:30 p.m.

The dress code is business casual (no jeans, tennis shoes or shorts).

A limited number of seats for the dinner might be available for purchase. Visit registration by the end of the day on Monday, April 25 to inquire.

ANNUAL MEETING SEATING

For the Annual Meeting, there will be open seating for all attendees. Voting this year will take place via mobile phone or a clicker provided during registration, so separate seating for guests is not

required. The 2022 Annual Meeting will be held over two days, starting at 3 p.m. on Wednesday, April 27. The second session will be on Thursday, April 28, starting at 9 a.m.

Attendees must be in their seats at least five minutes prior to the start of each session.

ATHLETE-DELEGATES

Athlete-delegates are represented at the highest policymaking levels. Bowlers designated as actively engaged athletes – top finishers at the 2021 USBC Open Championships, 2021 USBC Women's Championships and 2021 Junior Gold Championships, plus Team USA members within the past 10 years – are eligible to be delegates to the USBC Convention, and many have accepted the invitation to represent their fellow athletes. They have the same voting privileges as association delegates.

GUESTS/VISITORS

Family members and guests are welcome to attend the Annual Meeting. A special section is reserved for guests.

SPECIAL ASSISTANCE

Anyone requiring special accessibility or accommodations at the Annual Meeting should come to the registration desk, so arrangements can be made.

PROPOSED AMENDMENTS

One of the most important duties of a delegate is to vote on proposed legislation. The legislative session will take place Thursday, April 28. Please take a moment to thoroughly review the proposed amendments prior to attending the Annual Meeting. USBC encourages you to contact a regional manager in advance if you have any questions.

BOARD ELECTIONS

Delegates will vote on three open positions on the USBC Board of Directors. In this program, you will find information about the election procedures and biographies of the candidates slated by the USBC Nominating Committee. We encourage all voting delegates to attend the Meet the Candidates session on Wednesday, April 27 at 1 p.m. to hear from the candidates.



USBC YOUTH ADULT AWARD WINNERS



VOLUNTEER OF THE YEAR BILLY GASN Columbia, Maryland

Billy Gasn began volunteering at AMF Laurel Lanes where his son, Matt, was bowling in the youth league. At the time, the league was partnered with the Laurel Boys and Girls Club and required a fee to join. Billy assumed leadership of the league and decided it would be best to change it to a league that would pay scholarship money to the bowlers. In the first year, they were able to pay an excess of \$5,000 in scholarship money.

Billy Gasn went on to become involved in the Go for the Gold league at Greenway Bowl, offering youth a chance to qualify for Junior Gold. In 2004, he was asked to move the league, which led to it being moved to Fort Meade. This was the first youth Sport league in the area and still runs to this day.

In 2016, Bowlers Journal featured Gasn after he created the Mid Atlantic Youth Team Challenge, a youth Baker team event that drew 28 teams and paid out \$10,000 in scholarship money.

Recently, Gasn has had a large part in hosting a college bowling seminar for parents who are interested in having their children bowl collegiately. This program has been well-received and has resulted in plans for future seminars.



DAVID DAHMS COACH OF THE YEAR DIANE "DI" TORMANEN
Peoria, Arizona

Diane Tormanen started her career in the bowling industry in 1977 as a nursery attendant at Glenfair Lanes. She was fortunate enough to rise through the ranks and eventually was promoted to general manager of the bowling center.

Thursday, April 29, 2021

Call to Order

USBC President, Melissa McDaniel, welcomed the delegates and visitors to the 14th USBC Annual Meeting. The meeting was called to order at 1:10 p.m.

Meeting notices had been forwarded to all delegates in accordance with USBC Bylaws.

Board Introductions

USBC Executive Director, Chad Murphy, introduced the USBC Board of Directors.

National Anthem was played.

Memorial Video Tribute

Tribute was given to those who have passed away since the 2019 meeting.

Credential Report

Association Delegates - 1198 Athlete Delegates - 52 Hall of Fame Members - 12 Board of Directors - 18 Total Voting - 1280

IBC Youth Development Report

Gary Brown, IBC Youth Development Managing Director and IBC Youth Committee Chair, Chrissie Kent reported.

President's Report

USBC President, Melissa McDaniel, addressed the delegation and asked Past President, Karl Kielich to include a few remarks.

Strategic Planning Committee Report

Chairman Frank Wilkinson reported. Deputy Executive Director Jason Overstreet, reported on the SMART program and potential changes.

Executive Director's Report

Executive Director, Chad Murphy, addressed the delegation.

Approval of 2019 Annual Meeting Minutes

The minutes were approved as printed in the Delegate Program Book.

Nominating Committee Report

Chairman, Frank Wilkinson, the first order of business the delegation ratified the 2020 appoints to the USBC Board.

Six candidates ran for the three open spots on the USBC Board. Incumbent Jay Daryman of York, Pennsylvania; Dennis Hacker of Longtown, Missouri; Johnny Harris of Lynchburg, Virginia; Christy Lee of Tampa, Florida; and Jonathan Van Hees of Hope Valley, Rhode Island were slated by the USBC Nominating Committee and Sue Schreiber of Medford, Wisconsin ran from the floor.

USBC Board of Director Elections

On the first ballot, Lee received 437 votes, Hacker 378 and Daryman 351, and they were elected to the USBC Board.

All will serve 3-year terms beginning August 1, 2021.

An electronic ballot was used for the election.

Legislative Session

Jay Daryman, Chairman of the Legislative Committee, reviewed procedures to be used when considering proposed amendments

USBC President, Melissa McDaniel chaired the session. USBC Legal Counsel and Parliamentarian, Scott Beightol was virtual.

Both 2020 and 2021 legislation were voted on electronically.

Requires the use of a vacancy score until the person actually bowls.

Requires tournament managers to provide copies of prize lists and financial statements to tournament participants.

Rule 319c, Average Adjustments (Rerating) Limits the ability of a tournament manager to adjust a player's average upward for future events.

Amendment No. TR 3 – Rejected (61 accept, 569 reject)

Rule 319c, Average Adjustments (Rerating) Allows the player who has had their average adjusted in a commercial tournament to appeal this adjustment to USBC.

Amendment No. TR 4 – Rejected (24 accept, 600 reject)

USBC ANNUAL MEETING PROCEDURES

1. Delegates

Delegates must register and obtain delegates badges and confirm their voting method prior to the start of the meeting. Only delegates checked in and with a confirmed voting device or verified mobile device login will be eligible to vote. Seating will be open for all attendees.

2. Debate

While any USBC member has the right to debate a motion, only registered delegates may make motions.

- a. Any member entitled to speak shall go to a microphone
- b. Upon recognition by the presiding officer, the member shall state his/her name and association, and will have two minutes to speak
- c. A member may not speak a second time on any motion until all members who wish to speak a first time have been recognized and will have two minutes to speak

3. Secondary Amendments

To assist delegates who feel any of the proposed amendments are in need of change, and to conserve time on the meeting floor, the following procedure will be followed:

a. Any suggested changes should be submitted in writing to USBC Legal and Legislative chair or USBC staff at least 24 hours prior to the meeting

b. The suggested changes will be studied by the USBC Legal and Legislative Committee

c. In the event a secondary amendment to a proposed amendment is offered from the floor of the meeting which has not been considered as recommended above, it will be referred without debate to the USBC Legal and Legislative Committee. The USBC Legal and Legislative Committee will confer immediately with the proposer and report their recommendations to the delegation, except in those instances of minor changes which, in the judgment of the chair, raise no question(s)

4. Method of Voting

All votes shall be cast by electronic ballot, which shall be the sole method for determining votes unless the president, or in his/her absence the vice president, determines circumstances require a different method.

5. Parliamentary Authority

The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the meeting in all cases to which they are applicable and in which they are not inconsistent with the USBC Bylaws and these rules.

6. Adoption and Suspension of Rules

- a. These rules shall be adopted by a two-thirds vote.
- b. These rules may be suspended by a two-thirds vote.

ELECTION PROCEDURES BOARD OF DIRECTORS

USBC Board elections will take place Thursday, April 28, during the Annual Meeting.

The USBC Nominating Committee has slated five candidates for the three open positions on the board. Delegates will vote to determine the three board members who will serve three-year terms beginning Aug. 1, 2022.

Open athlete board positions are elected by athletes at a different time and are not part of this election process. The election for athlete board members is conducted according to the policies and procedures established by the Athletes Advisory Council.

Procedures

- 1. The Nominating Chair will outline the election process, present the slate, announce the names and read the biographies of the nominations from the floor. The Chair's reading of the biographies of the nominations from the floor will serve as the official motion to add the names to the ballot. (See Nomination from the Floor requirements below).
- 2. The USBC President oversees the balloting process, calls for the vote and announces the winners or the need for additional ballots. If the president is absent or on the ballot, the duties fall to the vice president. Should both the president and vice president be absent or on the ballot, the Nominating Committee Chair will oversee the process.

3. Voting

- All votes of the voting members shall be cast by electronic ballot, which shall be the sole method for determining votes unless the president, or in his/her absence the vice president, determines circumstances require a different method
- Only registered delegates wearing the official badge and lanyard will be eligible to vote
- Delegates must be in the delegate section in order to vote
- If a majority vote is not reached on the first ballot, the candidate having the lowest vote total shall be dropped from the list. If more than one candidate, balloting continues with remaining candidates until each position is filled by a majority vote. If there is an equal number of candidates to positions available and one candidate does not receive a majority vote, that position is declared vacant.

Nominations from the floor

In accordance with Article IV, Section B of the USBC Bylaws, nominees had to be submitted to the Nominating Committee, in writing, at least 30 days prior to opening of the Annual Meeting.

USBC NOMINATING COMMITTEE REPORT

Purpose: Prepares the slate for Board of Directors elections and selects the slate of Youth Committee members for Board approval.

The USBC Nominating Committee is tasked with building the future leadership of our organization. We take great pride in creating an inclusive process that considers all candidates who seek to serve on the Board of Directors and the International Bowling Campus (IBC) Youth Committee.

The committee is required to slate a minimum of three (3) candidates and may slate up to six (6) for the three (3) open positions on the USBC Board of Directors.

The committee evaluates candidates to fill the seats on the Board of Directors with qualified individuals who possess the skillsets identified to make the Board well-rounded and diverse. This process includes consideration based, but not limited to, on their professional resumes, education, and bowling industry experience.

For the 2022-23 election, the USBC Nominating Committee encouraged any person with the skillsets identified to apply:

- Candidate No. 1: A business leader who possesses some finance experience and who can bring innovation and inspiration to the board. An example is someone who currently is independent of our business structures.
- Candidate No. 2: A person with equipment, engineering background, and field expertise who easily collaborates with others.
- Candidate No. 3: A person with field experience, who knows and understands the association business as well as USBC and its business. An engaged association leader is an example.

USBC EQUIPMENT SPECIFICATIONS AND CERTIFICATIONS COMMITTEE REPORT



Purpose: Based on USBC strategic planning, this committee shall set direction to maintain and protect the integrity and credibility of the sport of bowling.

To uphold this purpose, the Equipment Specifications and Certification (ESC) Committee remains guided by the USBC vision "to continue to be the leading authority to the sport, servicing the needs of bowling."

The committee is responsible for reviewing and making final decisions regarding new items of equipment on which USBC approval is requested. The committee also is responsible for setting policies and procedures regarding equipment and specifications and for granting, withholding, suspending, withdrawing or otherwise regulating bowling center certificates.

As the National Governing Body for the sport of bowling, USBC executes its mission to "provide services, resources and the standards for the sport." Translating these bold statements into reality means engaging a world-class ESC team at the International Bowling Campus, USBC's home in Arlington, Texas. Our team of research engineers and research technicians invests significant resources in a continual effort to make sure your bowling experience is as fair as it is enjoyable and that bowling's future is ensured through thoughtful research, planning and delivery.

Over the past year, bowling continued to confront some unique challenges as the world slowly began to emerge from the brunt of the pandemic, yet we have persevered and remained united in sport. Through it all, USBC remained steadfast in its commitment to the sport and continued as much work as possible behind the scenes. Of note, in 2021, USBC:

- Tested and approved 246 bowling ball models
- Tested 31 additional bowling products (cleaners, polishes, lane surfaces, ball plug, lane conditioners, lane decals, embedded warnings)
- Issued 21 bowling pin permits
- Monitored center statuses as 3,871 active centers comprising 83,776 lane beds were logged

USBC has made significant progress in research and development of both existing and emerging specifications and technologies as part of its commitment to researching all aspects of the sport. In parallel with the ongoing "day-to-day" testing and approval process counts above, USBC often has ongoing active research projects that are often resource-intensive and viewed as currently or potentially impactful to bowling. Below is a highlight of USBC's engagement in 2021:

• String Pinsetters – If bowling had zodiac signs, 2021 was the Year of the String Pinsetter. Though at present not a USBC-approved product, string pinsetters were commissioned for study in 2020, with a preliminary report issued in early 2021. Testing into string technology primarily focuses on scoring and pinfall variables between these pinsetters and USBC-approved free-fall pinsetters. USBC engineers forged ahead and conducted extensive Bowlscore, league simulation, and E.A.R.L. testing.

Additionally, in-depth analysis was conducted on both the pins, strings and string length components utilized in the pinsetter setups. While the results were planned for delivery in **2022**, our research teams were able to hit a milestone and deliver a second comprehensive report in **September 2021**. Several factors affecting pinfall were identified and as such, preliminary specifications were proposed to string pinsetter manufacturers:

- o The string length has a minimum limit of 65 inches, measured from the ball cup to the point the string enters the pin.
- o Placing the pin curtain between 12-16 inches from the end of the lane, measured from the back of the tail plank.
- o Placing the ball stop cushion a minimum of 33 inches from the end of the lane, measured from the back of the tail plank.
- o Assuring the kickback walls on both sides of the lane have a minimum thickness of 2 3/4 inches.

These specifications were developed as a result of over **86,000** shots conducted on free-fall and string machines; to date, we have now catalogued results from over **130,000** shots and counting.

Collegiate – Collegiate bowling continues to be one of the growing segments in the bowling industry. USBC Collegiate had **143** schools and **4,250** members last season. The new system launched this season worked phenomenally and allowed for a more expedited process for tournament managers to compile results and submit them for the Team Ranking System.

USA Bowling Coaching – The USA Bowling Coaching program helps develop USA Bowling coaches. Last year, we had to adapt to the changes due to COVID, and we launched a new online USA Coaching seminar. Through this new innovative process, we still were able to floor 28 seminars with 418 individuals in attendance.

The coaching program has been our flagship program and by developing more USA Bowling coaches, which, in turn, help make it possible for the league concept to flourish. We provide a minimum of 50 seminars each year, at no charge to those who apply.

A new USA Bowling Development Manager was hired to work with centers and associations who were interested in launching USA youth leagues in their local market. This relaunch of the program went into seven different local markets and resulted in 125 new bowlers.

LEGAL AND LEGISLATIVE COMMITTEE REPORT



Purpose: Reviews proposed legislation, discusses items submitted by staff, other committees and if needed, may propose legislation or work with another committee to propose necessary legislation.

After a very busy 2020-2021, the workload of the Legislative Committee this past year has been substantially lighter. The fewest number of proposals in recent history were submitted for consideration, and only one (1) of these will be making it to the delegate floor at the 2022 Annual Meeting.

Additional revisions were made to keep USBC compliant under USOPC requirements for National

Governing Bodies (NGB). These changes include:

- Addition of USOPC compliance requirements to Rule 17b.
- Modifications to the USBC Code of Conduct.
- Modifications to the Conflict of Interest, Legal Compliance, Gifts, Resolution, Responsible Individuals and Whistle-blower policies.

Most importantly, USBC continues to deal with the challenges presented by the COVID-19 pandemic. Changes to allow the use of one lane in league play and isopropyl alcohol in competitions allowed league and tournaments to run in areas COVID-19 could have shut down have been extended through the 2021-2022 season. The Committee will continue to monitor conditions and make a recommendation to the USBC Board to continue or discontinue these COVID-19 related allowances.

In addition to the forgoing, we reviewed the proposed amendments that have been submitted and those advancing to the delegates for consideration can be found here.
